Minutes of November Meeting of Homestead Yacht Club

The meeting was called to order at 7.40 p.m. on November 1st by Commodore Bill Clemons.

Commodore Bill thanked Art and Maria Muina for the wonderful job they did with the Oktoberfest.

Secretary's Report: Sharon Roesch requested that the Minutes of the October meeting be amended as follows. It was noted that one member had partially paid his bill. The Club paid the remaining balance owed on behalf of the Club members, not Charley Sammarco as stated in the minutes. The minutes were approved with that correction.

Treasurer's Report. Current balance is \$5,258.44. Ending balance at 10/31/04 is \$5,190.98. Detailed Treasurers' report will be included in the Newsletter.

Newsletter: Bill Zinn indicated it was nice to know the end was in sight because someone else would be doing the Newsletter in 2005. Bill apologized to Dwayne Powell for failing to include, in the last Newsletter, membership statistics Dwayne had compiled

November Club function: Commodore Bill indicated that Saturday November 20 would be a busy week-end due to NASCAR race time, detours etc. and mentioned that it might be difficult to get to the marina. Members attending this event were advised to try the back roads and get to the marina early to avoid the heavy traffic.

Web Site: There was nothing new to report.

Sunshine Committee: There was nothing new to report.

Park Business: Janie thanked everyone who had donated candy to the charitable event held for kids. She advised that there was going to be a fishing tournament for kids on December 4, from ages 5 - 17. More information can be obtained from their website for information.

Ship's Store: Linda Clemons informed there was a lot of merchandise in the Ship's Store and the Club needed someone to take over this project in 2005 as she would no longer be able to do it.

Bill for the Coral Ridge Yacht Club event: Sharon Roesch advised that Chuck Burnitz had paid his bill and that Robert Tempkin had agreed to pay the Club for the remaining balance on his bill. Sharon read a note from Burnitz explaining what occurred and also advised that Larry Roesch had received phone calls from both members on the subject. George Mayer made a motion to reinstate both members in the Club. The motion was seconded and unanimously carried.

Membership: Dwayne Powell informed that the Club had 69 members. He introduced new members Robert and Lois Deane, Andy and Yaneth Vazquez who were presented with their burgees. Commodore Bill reminded everyone that the end of the year is membership renewal time and that the application forms to rejoin is posted on the web site at www.homesteadyachtclub.com. He asked that members fill out a new form (legibly) and submit the form along with their club dues to Dwayne Powell as soon as possible.

November event: Derek Boos provided information on the event which will be an Argentinian Pallayada BBQ of Black Angus Beef. Members were asked to bring one side dish that should be included on the sign up sheet located at each table. There will be Karoake with prizes, music and a dance competition. No hard liquor will be provided and members will have to bring their own bottle. The charge was \$5.00 per member and \$15.00 for guests. Commodore Bill advised that only immediate family living in the member's home are considered for the \$5.00 fee. Children under the age of 12 are free. Older children not living at home were required to pay \$15.00. Members were again reminded of the traffic caused by the races at the Speedway and that they should plan to arrive at the Marina early. The event would be held at the Pavilion, and it was expected that the Club would have lots of good food and fun. Commodore Bill reminded members they had to register for this event no later than November 15 so that the necessary supplies could be purchased, and a good headcount was necessary. Members were encouraged to pay ahead of time, and that if a member registered but did not pay, they had to pay at the pavilion.

With no other business to discuss, a motion was made, seconded and carried to adjourn the meeting at 8:45p.m.
