### Biscayne National Park Plans

During July, the Park Service held public meetings to discuss two proposed plans for changes in Biscayne National Park. One plan concerns Mooring Buoys and Markers within the park and the other plan addresses the establishment of Marine Reserve Zones in the park. In plain language, a Marine Reserve Zone is a No Fishing/No Take Zone. These were the first public meetings on both plans and at this point they are pretty much just looking for ideas of what the public would like to see included and excluded from the plans. I attended the meetings held in Homestead. Meetings were also held in Miami and Key Largo. Following are my observations/comments regarding the two meetings:

Mooring Buoy and Marker Plan: Even if you consider the Miami Herald reporter and the two Dade county representatives as members of the public, the Park Service employees still far outnumbered the public members attending. The mooring buoy portion of the plan is mainly directed toward the ship wrecks and other popular diving areas on the reef east of Elliott Key. It was suggested that in addition to installing additional mooring buoys, areas where it is safe to anchor without destroying the coral should be clearly marked. There was also discussion about possibly trying to control crowding in the vicinity of University Dock by installing and requiring the use of mooring buoys. The reason for the Marker portion of the plan was never clearly explained. They indicated that the responsibility for maintaining the markers, buoys, and signage within the park is already spelled out by various rules, regulations, and agreements. It was hinted that by including this in the Park's plan, it may be easier to get funding to accomplish it. The only thing that everyone seemed to agree upon was that the Featherbeds need to be more clearly marked.

Marine Reserve Zones: The purpose of these No Fishing/No Taking zones is to protect the fish population and enable Park visitors to view a natural reef with big fish. They presented numerous charts and graphs showing how the size and number of various fish types has continually declined over the years. Boating, snorkeling, diving, etc would still be permitted in the zones, just fishing and lobstering would not be permitted. A representative of the professional fishing captains complained that the fishing people are being unfairly picked on and that if these zones are necessary, then they should be no entry zones and not just no fishing zones. The general consensus was that if the zones must be established, they should be in a limited area east of Elliott Key and encompass some of the ship wrecks. One attendee also suggested that the Park start charging a user fee by requiring boaters in the Park to display some sort of sticker purchased from the Park. This would supposedly limit the number of people at the sand bar on weekends.

The Park Service will now put together initial drafts of the plans and then additional public meetings will be held.
