Biscayne Park Info

The following letter was sent out by the Park:

April 19, 2013

Dear Friends of Biscayne National Park,

As you may know, the National Park Service is working toward the completion of the General Management Plan / Environmental Impact Statement, which will guide the park's decision-making for the next two to three decades.

Next Steps

Because the plan will have long-lasting impacts, the park's staff carefully reviewed more than 18,000 comments we received on the 2011 Draft General Management Plan. Many of those comments had thoughtful suggestions that prompted us to reexamine certain aspects of the plan.

In conjunction with key partners, including the National Marine Fisheries Service (NMFS) and the Florida Fish and Wildlife Conservation Commission (FWC), we continue to use the best available science to develop a supplemental plan with one, or potentially more, modified alternatives. We expect to have the supplemental plan available this fall,



and will immediately seek additional public comment. We will widely publicize the public meetings which will follow the release of the draft supplemental plan.

Update Newsletter Available

A newsletter with the latest information concerning the General Management Plan / Environmental Impact Statement is <u>available to download as a PDF file here</u> as well as at <u>http://parkplanning.nps.gov/bisc</u>. The newsletter includes background information, current status of the plan, and next steps.

Biscayne National Park has a beautiful array of resources and is truly a gem of the National Park System. It is a park deeply loved and appreciated by generations of visitors. It is served by passionate and talented staff and volunteers, and actively supported by its partners and the greater Miami area. I look forward to working with everyone on continuing to refine the park's General Management Plan.
