



I just got off the phone with David Kennedy at Boat US. He is the head of their Government Affairs Committee. He shares our concern for the new rules that the NPS is trying to put in place to restrict anchoring in the park at our favorite areas. I have forwarded to him all of our documents about the situation here in South Dade. He assured me that they will be issuing an alert by tomorrow about this situation. He wholeheartedly agreed, that the only way to stop or delay this ridiculous attempt to keep us out of our park, is by volume of complaints and comments against this plan. If you haven't already done so please comment on your displeasure about this situation. The only answer is "Alternative A" no action at this time. Everyone in your household, your friends, your neighbors, and non beaters alike should go to the web site and comment. We will have a detailed

This has included their Master Plan, their Fishery Plan, and most recently, the Mooring Buoy and Marker Plan. I have repeatedly asked Park personnel if there is any truth to the rumor that they intend to install mooring buoys in the Bay and was always told NO. Then suddenly, under the guise of protecting Park resources and public safety, mooring buoys show up in this latest plan as a means of restricting the number of boats in several areas of the park, including the University Dock/Sand Bar area. As stated by Commodore Larry, if you have not yet submitted your objection to this plan, please do so before the Sept 3rd comment deadline. Park Service Mooring Buoy Plan

On August 3rd several members of the Homestead and Black Point Yacht Clubs attended a public meeting in Florida City to review and comment on the Park Service's Mooring Buoy Plan for Biscayne National Park. The Plan involves mainly the use of signage, markers, and buoys to protect the reef, ship wrecks, and grass beds within the Park. The Park Service explained their basis for developing the Plan and then the public was invited to offer comments. Several members of both Yacht Clubs addressed the meeting. There was almost universal agreement with the idea of placing more mooring buoys in the vicinity of the reef and the ship wrecks and not permitting boaters to drop anchor in those areas. The proposal to add additional signage and channel markers within the park was also well received. However, there was unanimous objection to the portion of the Plan which calls for the use of mooring buoys to control the number of boats that congregate on weekends and holidays at the sand bars near Stiltsville and Sands Cut, and in the anchorage near University Dock. Superintendent Lewis stated that he did not have a sufficient number of rangers to adequately patrol those areas on weekends and that he actually feared for the safety of the rangers when they have to respond to an incident at the Sands Cut sand bar. The majority of the discussion and public comment centered around the Sands Cut sand bar and at times it was hard to believe that the Park Service personnel and the members of the public were talking about the same area. The Park Service describing the area as an out of control collection of drunks engaged in frequent fist fights, knife fights, etc while the members of the public referred to it as a family friendly shallow water area where they can take their kids and enjoy family time together with friends. Some addressed the fact that they had gone to the sand bar with their parents when they were children and they now take their children there and they don't want to see that enjoyment taken away. Most acknowledged that the west end of the sand bar can get pretty noisy and rowdy at times, but encouraged more law enforcement as the way to control that, rather than virtually closing the area to public access and punishing all because a few misbehaved. It was also pointed out that with the possible exception of some trash, the boaters who congregate at the sand bar are not damaging any park resources because the sand bar is cleaned/restored with each change of the tide. Several speakers expressed the opinion that if boaters are not permitted to used the Sands Cut sand bar, they will just find somewhere else in the Park to congregate, probably somewhere where they are actually damaging park resources. Regarding the University Dock anchorage area, it was pointed out that this is a well established and marked anchorage area and that the bottom there is virtually a waste land, with no vegetation. It was suggested that rather than try to limit anchoring in that area, the Park's efforts should be concentrated on areas such as the grass bed north of Sands Key where the anchoring of boats can actually damage something. After much, largely repetitious, discussion was concluded, Superintendent Lewis thanked everyone for attending and stated that several issues had been raised which will require serious review before they proceed with the plan. As it is presently written, the plan does not specify a number of buoys to be set up at any of the Elliott Key locations other than Billy's Point where there are supposed to be ten buoys. In response to an e-mail from the Black Point Yacht Club, Superintendent Lewis advised that they envisioned approximately 70 buoys in the University Dock area. He concluded his e-mail with the statement that they want to "provide the opportunity for people to enjoy and experience one of the natural wonders of our nation." I have trouble understanding how putting 70 buoys in one area can contribute to the natural beauty of the area. This plan has the potential to significantly impact how you enjoy boating in the Park, so if you have not yet submitted your comments, please do so before the September 3rd deadline.
