🚤 George thanked the members who sponsored the pig roast and noted that it was a huge success!

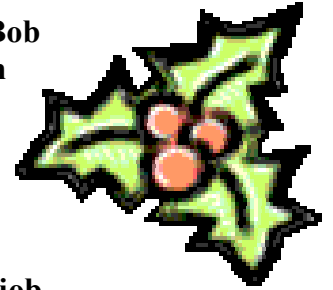
🚤 Bill Clemons advised that anyone coming to the shrimp boil at Bayside feel free to bring an appetizer or dessert.
