Monday, June 2, 2008**

Commodore Dave called the meeting to order at 7.40 p.m.

Sharon Roesch informed that a correction was needed to the Treasurer's Report indicating that at April 1 the balance was \$5,992.21, whereas this balance should be \$5,199.21.

A request was made by Ray Vega to get on the mailing list for the newsletter since he had problems opening his newsletter on line. Bill Clemons informed that something was wrong with the copy he received as well. Commodore Dave said he would pass along the information to the editor.

Park News: Buzz Strandhagen informed that "A" dock should be finished by the end of June if no delays from FPL.

Treasurer's Report:

Beginning balance \$5,032.09

Ending Balance \$5,126.09

Membership: Dwayne Powell informed the club had 42 memberships advising also that we had a potential new member, Jane Jones attending the meeting.

Sunshine Committee: Jan Meyer informed that everyone was healthy, and welcomed Bill Zinn back who attended.

Ship's Store: A report would be given after dinner. This report was not given because the ship's store was not opened.

Roster: There was nothing new to report. However, if members change their contact information, please remember to send the new information to Sandy Zinn. This will ensure you receive a newsletter and any other communication from the Yacht Club.

Web Site: Larry Roesch informed there was nothing new to report. However, for members who want to check out the newsletters, they are all downloaded on the web site. Information on upcoming events can also be found on the website.

July Meeting: There will be no July Meeting. Commodore Dave proposed canceling the July meeting since it would fall on the long weekend when most members would be away. A motion was made by Dwayne Powell and seconded by Ken Johnson to cancel the July meeting. Motion unanimously carried by a show of hands. The next club meeting will be held the first Monday in August 2008.

Events:

Commodore Dave informed there was a meet and greet planned for June 28 between 3:00 – 5:00 p.m. at the Parking lot between “B” and “C” docks. Event to be hosted by Buzz Strandhagen and Jerry Cline. Hot dogs and hamburgers, slaw, cold soft drinks and water would be served. Members charge is \$5.00. Per person. Sharon Roesch volunteered to make her big batch cookies and received a round of applause for that offer. A show of hands indicated 22 club members wanting to attend. The event is to meet marina patrons and drive membership for the club. A budget of \$300 was allocated by Commodore Dave for this event. Signs will be placed on the gates prior to the event and communication will go out to the membership to inform them. It was suggested that a reservation list be created in order to collect the funds, which Sharon Roesch offered to do. A motion was made by Ted Newlan and seconded by Larry Roesch, which carried:

New Business: Commodore Dave informed that the Redlands Country Club had a new person taking over the Banquet Services and a price increase was being considered. He would inform the membership as soon as this information becomes available.

The 50/50 of \$57.00 was won by Charlene Powell who did a dance and a jig for being a first timer to win.

There being no other business to discuss, a motion was made by Claire Strandhagen and seconded by George McDermot to close the meeting.
