City of Miami increases Marina slip fees

On February 12, Club member Dwayne Powell was notified by the City of Miami that the fee for the slip where he was keeping his sail boat, at Dinner Key Marina, was being raised from \$450 to over \$850. This action prompted the following item from Dwayne:

SHORTAGE OF DOCKAGE SPACE JUSTIFIES INCREASE?

The Wednesday, February 19, 2003 Miami Herald quotes Miami City Commissioner Johnny Winton as follows:

"Shortage of dockage space is exactly why the increase is justified. I don't think it's fair for the rest of the citizens of the city to have a public facility where we are undercharging people. If they don't have a choice, then that doesn't mean we are ripping you off" Commissioner Winton is referring to the recent almost doubling of rates at Dinner Key Marina with a two- week notice to its patrons. Certainly, no one would question a marina's right to charge a fair rate. Most people probably do not see any reason to shed tears over a bunch of yacht owners.

However, there are no Trumps, Kennedys or Rockefellers at Dinner Key Marina but instead the large majority are hard working individuals who live on a budget. A large number have lived on their boat at Dinner Key Marina for decades. Many work in the marina industry- marine mechanics, boat repairs, sail makers, shrimpers. Many live and work at the marina. Some are retired and living on a fixed income.

I respectively disagree with Commissioner Winton. Frankly, I question whether the increase in rates is legal but whether it is legal or not it is a rip off and it is wrong. I considered mentioning unethical but I will let you come to your own conclusion on ethics. Miami City Mayor Diaz is a partner in Monty's which charges an outrageous rate for its dockage. In addition, the new private Grove Key Marina, which the city sold to a private company, has high rates. Now with the increase in the Dinner Key Marina rates boaters have a choice of high rates. Wow! That is brilliant!

I urge you to consider voicing your disapproval of the Dinner Key rip off by writing a letter to the Miami Herald or send a short e-mail to HeraldEd@herald.com.

Why should you worry? Well, first if you are a boater in Dade County you will probably be next. It could be increased dockage or ramp fees at county parks. It may be increased costs in bait or work on your boat. It may not have anything to do with boats. Politicians understand public opinion. Take a few minutes and voice yours or pay later.

For the record Charlene and I have moved "Charley Girl' back to the marina we first fell in love with-Homestead Bayfront.

Editors Note: In a February 19th article regarding the fee increases, the Miami Herald pointed out that two private marinas in the area charge as much as \$620 and \$936 per month and then stated, "The six marinas owned by Miami-Dade County charge roughly \$400 a month." Think that might give the County Commission an idea?

Boat US-West Marine

In January, Boat US announced that they have sold their retail store and catalog sales operations to West Marine. Other Boat US services such as their insurance, marina discounts, and emergency towing will not change as a result of this action.

Lobster Season Options Discussed

According to a recent article in the Miami Herald, the Florida Fish & Wildlife Conservation Commission recently held a series of public meetings seeking comments on proposed management options for lobster in South Florida. Among the options proposed by the Commission are: A special \$10 mini-season permit for lobster hunters in the Keys, increased enforcement of the six lobsters per person per day bag limit, more effort to prohibit divers from placing objects in the water to create lobster habitats, and Setting commercial dive trip limits. The meetings were held between February 18th and 20th in Key West, Marathon, and at the Crowne Plaza Hotel on Lejeune Rd in Miami. The outcome of the meetings was not reported by the Herald; however, the Keys News reported that the general sentiment of the Key West meeting was, Lets Get Rid of Mini Season. Considering the meeting locations, it would appear as though the Commission feels that no one in the Cutler Ridge, Homestead, or Key Largo areas is interested in the taking of lobsters.
