#### **National Park's No Fishing Plan**

According to a report in the *Miami Herald*, the National Park Service has run into some serious opposition to their plan to establish No Fishing zones in Biscayne National Park. The Park claims that the zones are needed to restore a dwindling fish population and to protect endangered reefs. The zones are included in the Park's general management plan which is expected to be completed by the end of the year. Opposition has been raised by three Florida members of Congress (Ros-Lehtinen, Rivera, and Diaz-Balart) and the Florida Fish and Wildlife Conservation Commission (FWC). The three Legislators have submitted a letter to the House subcommittee on National Parks, Forests and Public Land requesting an oversight hearing on the Park's plan. The FWC maintains that only the State can impose a No Fishing zone and at present they are not convinced that such zones are necessary. Of course, the Park Service claims that they have the authority to restrict fishing inside the Park. So for now, they have agreed to disagree. The Park is also in the process of reviewing more than 18,000 comments submitted by the public following a series of public hearings held in August of last year. Supposedly the public comments are taken into consideration when their plan is finalized.
