Membership: Dwayne happily reported the addition of three new members. Cmdr. Dave presented Ron Wise, Donna Pacheco and Linda Wood with burgees.

Teresa Dean reminded us that the October event is a Halloween Party, costumes mandatory, scheduled for October 27th at 6:30 p.m. She had recipes for members to choose and a sign up sheet.

November event: The Saturday after Thanksgiving, fried turkey, held "under the bridge" which I understand is code for Larry and Sharon's house.

50/50 of \$28.00 and another drawing for one takeout dinner both won by Cmdr. Dave. Meeting closed at 8:07 p.m.

Motions Passed

A review of monthly meeting minutes for the period November 2001 to September 2012 revealed that the following motions related to Club operations etc were made and approved:

Nov 2001: Agreed not to read the minutes of the previous meeting at the monthly meeting. Since the minutes are published in the Newsletter and thus can be read by members prior to the meeting, a simple motion to approve the minutes as published in the newsletter will be acceptable in lieu of reading the minutes.

Nov 2001: Monthly newsletter will be sent only by e-mail to those members with e-mail addresses. Printed copies will be mailed only to members who do not have e-mail addresses or who specifically request a printed copy.

May 2003: When space permits, members can have their business card or a business card size ad included in the Newsletter.

Nov 2003: Agreed that Club would not send a letter complaining about problems in the Homestead marina but rather members were encouraged to send individual letters. It was felt that multiple letters were more effective than a single letter.

Oct 2004: Memberships of two members were terminated due to behavior issues and failure to pay their bill following a club event at Coral Reef Yacht Club. In Nov 2004 their memberships were reinstated after the bills were paid and behavior issues addressed.

Feb 2006: Agreed that Club would send a card rather than flowers to members in the event of illness or death in the family except for the death of a member, spouse, or child in which case flowers will still be sent.

Oct 2006: Members of the bridge will each receive a burgee and a plaque to be paid for by the club. Gifts to other members who volunteer for jobs to support the Commodore will be at the discretion of the Commodore and be paid for by the Commodore.

Oct 2006: Initiation/Burgee fee for new members is increased from \$20 to \$25. Yearly fee for new members is now \$85 (\$25 plus \$60).

Aug 2007: Agreed to provide Homestead Marina with an HYC flag (large burgee) to display on their flag pole.

Mar 2008: Team formed to review Club's spending practices on events and possibility of establishing a yearly budget. Team's recommendations were submitted at the April meeting; however, no action was taken.

Aug 2008: Agreed to continue to hold monthly meetings at Redland Country Club until after the change of watch event in January. This issue surfaced as a result of the County Club implementing a \$100 a month fee to use the meeting room.

Sept 2008: Yearly dues increased to \$80 effective Jan 1, 2009 (remained \$60 if paid prior to Jan 1). New members will be charged an additional \$25 to cover the cost of burgee.

Oct 2009: Agreed that members would be charged \$10 per year to have a printed copy of the Newsletter mailed to them each month.

Mar 2011: Motion approved to move monthly meeting from Redland Country Club to the Capri Restaurant.

Nov 2011: Agreed to leave annual dues at \$80. New members to be charged \$25 if they want a Club burgee.
