Biscayne National Park has announced that they will soon be releasing proposed changes to their General Management Plan. Once the revisions are published, a 90 day public review and comment period will be scheduled. These revisions are in response to over 18,000 public comments they received after the original version of the Plan was released in 2011. Most of the comments concerned protection of the reef and fishing/boating restrictions within the Park.

Columbus Day Regatta

The 2013 Columbus Day Regatta will be held on the weekend of 11-14 October. Historically, in conjunction with the Regatta, large numbers of boaters have congregated in the Bay, off of northern Elliott Key, to party. As has become normal, Biscayne National Park has imposed restrictions on where you can anchor, how many boats can be in a raft-up, distance required between boats, etc. While these rules are imposed under the guise of safety and protection of Park resources, they appear to be designed mainly to discourage people from gathering and partying in the Park. A recent Park news release carried the following headline; "Biscayne National Park discourages boaters from congregating in the Park over Columbus Day weekend" Their efforts have obviously been successful as the event, which was once considered the largest clothing optional boating event in the country with partying boaters as far as the eye could see, is now essentially a relatively quiet peaceful raft-up. If you do plan to participate this year, please remember that there will be law enforcement personnel from every local, state and federal agency in the area on patrol in the anchorage area. They have stated that there will be a zero tolerance for drinking while boating and that everyone should remember "Park at Dark". In other words, anyone caught boating in the anchorage area after dark will probably be stopped, even if properly lighted. Pamphlets detailing all the Regatta restrictions are being distributed at local bait and tackle and marine equipment stores as well on the Park's web site.
