Columbus Day Regatta October 11, 2014. Looks like the park will be open for your enjoyment, rules to follow:



COLUMBUS DAY WEEKEND: WHAT YOU SHOULD KNOW
BEFORE YOU ENTER BISCAYNE NATIONAL PARK

Each year on Columbus Day Weekend a large gathering commonly known as the Columbus Day Regatta commences within Biscayne National Park. A regatta, however, isa sailboat race and should not be confused with the remnant activity that now exists. This large gathering of boats has been the site of numerous incidents, including a wide variety of criminal violations, environmental impacts, medical emergencies and loss of life.

Biscayne National Park is responsible for protecting and preserving some of our nation's most significant resources, whether natural, cultural or recreational. For resource protection and your own safety, please boat responsibly and comply with all regulations. The National Park Service and cooperating federal, state and local law enforcement agencies will step up enforcement of applicable laws and regulations with zero tolerance for violations: These include:

Offense I	Fines, and/or 6 Months in Jail
Boating under the influence (BUI):	\$775 - \$5,000
Excessive noise/music, Littering:	\$125 - \$5,000
Sale or gift of alcohol to a minor,	
A minor in possession of alcohol:	\$125 - \$5,000
Public intoxication, or Possession of controlled	l substance: \$325 - \$5,000
Fighting, Threatening or violent behavior	\$525 - \$5,000
Rafting in excess of 5 boats "5 Boat Rule":	\$125 - \$5,000
	(Per boat in violation)
Running aground/Damage restoration:	\$175 - Additional assessment
Boating and equipment violations:	\$75 - \$5,000
Reckless and negligent boat operations:	\$525 - \$5,000
Operating personal watercraft (PWC):	\$125 - \$5,000
Unauthorized business operations:	\$525 - \$5,000
Unmanned aircraft (drones, model planes, quad	copter cameras, etc.): \$100 - \$5,000
